On 01/21/2021, I (Officer Vann #602) was dispatched to 2475 Apalachee Parkway (Corner Pocket) in reference to a bomb threat. Call notes indicated the caller overheard a white male wearing all camouflage clothing talking about having a bomb at the Capitol and it was going to go off at 08:00am.

Upon arrival, I met with a white male who was sitting outside the bar who was wearing all green camouflage clothing and a Ford hat. The male was later identified as Mark Clark by Florida Driver's License. Clark asked and I advised yes. I told him it was because of statements being made about the

Capitol. Clark laughed and stated

I walked into the bar and spoke with the manager (Samantha Helms // identified by Florida Driver's License) who advised she wanted Clark trespassed and he is the one her employee called about. I then went and spoke with Jada Watkins (employee). Watkins advised she was sweeping outside while Clark was speaking mostly gibberish and saying "hi" multiple times. Watkins stated she gave him a fake name since he was acting strange and as she was walking away, Clark stated

Watkins stated he began to laugh a lot and she went inside to call police. Watkins also advised she has never seen Clark before and does not know who he is.

Watkins provided a sworn written statement.

I escorted Clark off the premises and informed my chain of command about the incident. Capitol Police was also contacted about the above information. Clark was read his Miranda Rights via my department issued Miranda warning card. Clark verbally acknowledged his rights and was willing to speak with me. I asked Clark multiple times about the bomb statement; however,

Clark was then placed under arrest for Florida State Statute 790.164 (Providing a false report concerning planting a bomb on State property).

Charge:

Mark Clark did unlawfully and knowingly

- 1. Make a false report to any person (Jada Watkins) concerning the placing or planting of a bomb on property;
- 2. The property was owned by the State of Florida (Capitol building);
- 3. The defendant knew the report was false;
- 4. The report was made with the intent to deceive, mislead or otherwise misinform any person.

Therefore, there is probable cause Mark Clark violated Florida Statute 790.164 (False Report of Bomb on Property Owned by the State).

Clark was searched with negative findings and placed into the back of my marked patrol vehicle. I also looked for any suspicious devices around Clark's Red Ford Ranger (Florida Tag CMC H15), as well as under the vehicle, with negative findings. It should be noted I did not conduct a search of the vehicle, but simply looked from the outside of the vehicle.
